

## IMPLEMENTATION OF THE TSHWANE TOWN-PLANNING SCHEME, 2008: INFORMATION SHEET

### 1. OLD APPLICATIONS

- Rezoning and Township applications submitted in terms of the former six Town-Planning Schemes up until 18 June 2008, will be finalised and promulgated in terms of the relevant former Town-Planning Scheme.
- All other types of applications submitted in terms of the former six Town-Planning Schemes up until 18 June 2008, will be finalised in terms of the relevant former Town-Planning Scheme.

### 2. APPLICATIONS IN TERMS OF THE TSHWANE TOWN-PLANNING SCHEME, 2008

- The Tshwane Town-Planning Scheme, 2008 comes into operation on 19 June 2008.
- All land use applications submitted on and after the 19 June 2008 must be lodged in terms of the Tshwane Town-Planning Scheme, 2008.
- No applications submitted in terms of the former six Town-Planning Schemes will be accepted as from 19 June 2008

#### 2.1 INFORMATION NEEDED BEFORE SUBMISSION OF LAND USE APPLICATIONS

- The Tshwane Town-Planning Scheme, 2008 and revised Application Manuals will be available at the Land Use Information Counters as from 09 June 2008
